

Reminder: 2023 W-2 and 1095-C Paperless Option


This is a reminder to the notification provided on <u>June 30, 2023</u>. The National Finance Center (NFC) is encouraging all employees to choose the paperless option for their 2023 Internal Revenue Services (IRS) Form W-2, Wage and Tax Statement, and 1095-C Form, Employer-Provided Health Insurance Option.

The paperless option can be accessed through the Employee Personal Page (EPP). A feature has been added in EPP under the Preferences tab called "Change Paper W-2/1095-C" to enable employees to "opt out" of the paper option. Employees wishing to make this election must do so by 12:00 a.m. (midnight) CST on **December 1, 2023**. If no election is made, employees will receive a mailed copy of both forms.

A pop-up message was added to the Employee Personal Page (EPP) to prompt employees to OPT OUT of having their W-2/1095-C mailed. The frequency of the reminder will be every time the users log into EPP applications and have not signed up for the paperless option for W-2 and 1095-C. The message will be displayed after the user confirms the Address Verification pop-up.

In addition, if an employee has already made this election to "opt out", no action is needed. The employee will remain in the same status of paperless.

Below you will see an example of how to "opt out" of receiving paper copies of both W-2/1095-C.
