#### **Updated FMMI Payroll Processing**

During the Thursday, April 18, 2019, O&M teleconference, the extremely high volume of payroll data to be processed during Pay Period 07 FMMI payroll processing was discussed. This volume was to include retroactive pay from the beginning of 2019. The Payroll Splitter mainframe job for Pay Period 07 did not complete processing until Sunday morning.

The FMMI input files totaled **3,988,038 records**. This is compared to a normal payroll weekend of about 320,000 records. A decision was made to split processing of the input files over four days to alleviate possible processing issues that may occur in the backend systems (in particular BI and FSDW).

Twenty-four of the 29 agencies, totaling **1,719,913** records,were processed into FMMI through the last two days. A decision was also made to move the FSA Payroll

processing to Wednesday, due to an issue identified with the volume **1,275,188 records** of data that will process.

Below is our plan to complete the payroll processing for the remaining FMMI agencies:
