- 1. TOMB The January 29, 2022, Systems Maintenance will be moved to January 22, 2022, because of potential impact to month-and quarter-end processing. FMS is cognizant of it being a payroll processing weekend, provisions have already been put in place to avoid negative impacts. FMS will send a detailed notification to agencies prior the upcoming January System maintenance changes.
 - a. FMS FMMI Production Systems (ECC) will be temporarily unavailable for scheduled maintenance (SUSE/HANA Upgrades) beginning at 8:00 a.m. CT thru 5:00 p.m. CT Saturday, January 8, 2022.
 - b. TARD When operating system updates happen is there post testing preformed to avoid negative impact to BI (e.g., commitment string issue? Yes, every time we conduct system maintenance, we do post testing. TARD encouraged agencies after the refresh is completed to thoroughly review their DATA Act reports and report any anomalies asap.
 - c. OCIO/CEC Will the speed of running Ad Hoc reports in FMMI be impacted by the weekend maintenance updates. No, it should not. If response time occur submit a ticket.
 - d. FPAC-BC Submitted a ticket for a specific BI issue is there a default fix? Basis Team will forward ticket number to Report Design and Development Team for follow-up.
- 2. PSB Today, January 6, 2022 is the cutoff for employees and former employees to submit their outstanding 2017-2020 RITA claim(s) to the agency. If claim(s) are not received by the submission date, agencies should establish bills for the Withholding Tax Allowance (WTA) that was paid to the relocating employees in a specific calendar year.
