

On April 18, 2014, the following changes were implemented into the CPAIS Real Property Application:

CR 199367 - Allow Zero Personnel and Workstations for Excess and Abandoned Assets

- FRPP Data Gap Detection Processes
- The CPAIS processes that review real property asset records and identify the FRPP reportable assets plus their data gaps or data errors was revised to allow zeroes in the No. of Personnel, No. of Workstations, and calculated Utilization Percentage fields for asset records with a Property Type indicating leased or owned property and a Predominant Usage of Office.

CR 270287 - Add/Modify Predominant Usage Subcategory Values

- Removed the link to the Utilization form.
- Removed the link to the Explorer-Rooms Without Occupants form.
- User View Modifications
 - Added a Utilization column/pick field to all building related User Views that contain a Utilization Rate field.
- Explorer-Property Form-Buildings Tab Modifications
 - Removed the Occupancy Block.
 - Expanded the Floor/Room Usage Block to fill the available area.
 - Added a Utilization column to the Buildings Data Block placed to the right of the Utilization % field. Populated this field with the derived word value for Utilization based.
 - Utilization field is read-only but the list of values (LOV) is provided for query purposes only.
 - Removed the reference to square footage (SF) from the Design Capacity and Occupied Space column titles.
- Property Form-Buildings Tab Modifications
 - Removed the Occupancy Block.
 - Expanded the Floor/Room Usage Block to fill the available area.
 - Added a tab to the right of the Address tab labeled "Utilization".
 - Added an Agreement button left justified below the icon bar and above the title bar that launches the Collocation Agreement form when applicable.
- Property Form-Buildings Tab-Details Cont Subtab Modification:

- Removed the Design Capacity SF, Occupied Space SF, and Utilization % fields.
- Property Form-Buildings Tab Functionality
 - Selecting the new subtab labeled “Utilization” will display the new Occupancy/Utilization Subtab.
 - Added Agreement Button.
- New Property Form-Buildings Tab-Occupancy/Utilization Subtab Functionality
 - If Predominant Use is equal to “Office”

The Utilization Block fields are read-only and auto-populated per the data entered in the Office Utilization Workspace Block except for the fields indicated below. These fields are available for data entry regardless of the Predominant Use value:

Available Vacant Space

Space Available

The Office Utilization Workspace Block is available for data entry.

To save a row, all fields in the Office Utilization Workspace Block must be entered.

- If Predominant Use is not equal to “Office”:
 - The Utilization Block is available for data entry.
 - The Office Utilization Workspace Block is not available for data entry.
 - The Office Space Allocation Block is available for all Predominant Use values.

CR 316487 - Populate Country Data Instead of County Data in the Country Field

- Country Column Population
- The CPAIS processes was revised to populate the Country column on the Explorer: FRPP Assets form with country data.
- The processes was modified to display UNITED STATES the Country column for FRPP-reportable assets with US addresses and to use/display the County/Country value in the

Country column for foreign addresses.

CR 484261 - Add Trigger to Populate CREATED_BY, CREATED_DATE, MODIFIED_BY and MODIFIED_DATE Columns in the DEV_STATUS_HISTORY Table.

- Insert of DEV_STATUS_HISTORY Table Data – Upon insert of data rows in the DEV_STATUS_HISTORY table, database triggers populate the CREATED_BY and CREATED_DATE fields.
- Modification of DEV_STATUS_HISTORY Table Data – Upon update/modification of data rows in the DEV_STATUS_HISTORY table, database triggers to populate the MODIFIED_BY and MODIFIED_DATE fields.
- Correction of Current Data Stored in the DEV_STATUS_HISTORY Table – A process was developed to do a one-time population of the data currently missing in the DEV_STATUS_HISTORY table. All data rows in the DEV_STATUS_HISTORY table have data in the CREATED_BY, CREATED_DATE, MODIFIED_BY and MODIFIED_DATE data fields.

CR 582718 – Freeze the Footprint Tracking Report

- CPAIS Reports Menu Modifications
 - The Real Property Management (RPM) reports menu include the Freeze the Footprint Tracking Report.
- Baseline Square Footage Data
 - Created a new data repository to store the baseline square footage data.
- New Report
 - Create a new Freeze the Footprint Tracking Report.
