<b>Scope:</b>	<p>On September 1, 2023, the OPM Director announced the release of final regulations to implement the Fair Chance to Compete for Jobs Act of 2019 (the Fair Chance Act). This Act requires agency Human Resource offices to issue, and document written warnings, suspensions, and civil penalties.</p> <p>The scope of the project is to no longer require remark code S49 when processing a Nature of Action Code 450 with Legal Authority Codes (LACs) VAO, VAP, VAQ, VAR, and VAS. These LACs each necessitate a specific required remark code that aligns with 5 U.S.C. 9202.</p> <p>Edits will be implemented when processing a 450 action to require the appropriate remark code as indicated in the Guide to Processing Personnel Actions (<a href="https://www.opm.gov/policy-data-oversight/data-analysis-documentation/personnel-documentation/processing-personnel-actions/gppa15.pdf">https://www.opm.gov/policy-data-oversight/data-analysis-documentation/personnel-documentation/processing-personnel-actions/gppa15.pdf</a>)</p>
<b>Assumptions:</b>	<p>The new LACs and remark codes have been implemented in project 74624.</p> <p>Update TMGT101 on NOAC 450 to remove the required S49 remark code.</p> <p>The new page in EmpowHR to maintain remark codes will be given access to developers in HRDEV and read-only access to other environments.</p> <p>Remark code <b>S49</b> shall remain required when NOA 450 is with the Legal Auth Code: VAA, VAB, (V4J and ZEM), (VAV and ZEM), VAC, VWJ, VDS, (VAD and USP), (VAE and USR), USP, and USR.</p> <p>Table 047 will be updated to add new error code 450 - REMARK CODE S60 S61 S62 S63 or S64 MUST BE PRESENT.</p>

The new page will be developed as follows:

- Security access for this table will be limited access only to development that will be similar to Table 101. Security role Z\_STAT\_DEVELOPERS will grant update access to this page.
- Include the fields Legal Authority code 1 and Legal Authority code 2, Last Updated Userid and Last updated date time fields to the config table Z\_NFC\_RQRD\_RMRK.

Currently the code to auto populate PAR Remarks based on NOA code exists in production. Modify this code to include Legal Authority Code based logic as follows:

- If legal authority is not populated(blank) in the config table PS\_Z\_PI\_RMK\_EDTLST, then the required remark for the NOA is auto populated.
- If legal authority is populated in the config table, then current PAR row legal authority must match with the legal authority on the config table to auto populate the required remarks.

Update the Z\_NFC\_RQRD\_RMRK config table to require the following remark code when NOA Code is 450 with the Legal Authority code combination below:

VAO S60 - Suspension is for a second violation of 5 USC 9202.

VAP S61 - Suspension is for a third violation of 5 USC 9202.
