F Human Resources Applications Branch (HRAB) Requirements

Update the PAR Processing for EmpowHR menu: HR Processing - Personal Data Tab: Citizenship Block.

Currently, on a PAR action if the processor selects a non-US country and then chooses an "8" for "Other" in the Citizenship field:

- A message error displays: Invalid -Value for several of the values
- The values on the drop-down are not the OPM assigned values
- The non-US country does not export to NFC PPS

Additionally,

- the Country field is designated as required with * when in fact, it is not required
- the Citizenship field is not designated as required and it should be required

In effect, this field/ information should be completed on the payroll document 444-EHRI/RSM under the EHRI RSM Data box. There is a dropdown that lists the OPM assigned codes for the countries to select

Update EMPOWHR to Gray out the "*Country" field on the PAR processing menu. This will eliminate any data entry in this field and be consistent with other NFC systems.

Update EMPOWHR to remove the * from the "*Country" field.

Update EMPOWHR to add the * to the "Citizenship" field.

Add an informational message, when the user selects "8" for Citizenship:

"Submit Document Type 444 EHRI & RSM ELEMENTS to designate the Country Code"

This edit shall be activated upon save.
