

## Payroll/Personnel System - Calendar Year 2013, Pay Period 12 Release Notes

Effective Pay Period (PP) 12, 2013, the following Agency-specific and community-wide changes will be implemented in the National Finance Center's (NFC) Payroll/Personnel System. The high-level summary table shown below references the incident and project number, identifies whether the project is an Agency-specific or community-wide change, states the project title, and gives a brief description of the change.
