### **Purpose**

Use this procedure to clear the Work in Progress (WIP) Rejects that are listed on the Exception table in FMMI.

### **Trigger**

Perform this procedure when documents are failing to the Exception table for various reasons. This would take place when documents fail to interface from FMMI to CPAIS-Personal Property and are in a reject status on the Exception Table.

#### **Procedure**

- **1.** The Property Accounting Section (PAS) will download the Exception Table and export the results to an Excel document to analyze.
- **2.** The PAS will then analyze the exported document by filtering for the WIP Rejects that are Settlement (S1) Documents in order to see what agencies are affected.
- **3.** The PAS will reach out to each agency's Point of Contact and provide them with the document numbers listed on the Exception Table to decide how to move forward on each document.
- **4.** If the agency wants the document to be cleared from the Exception Table and interfaced to CPAIS-PP, they will need to first address the error message on the document so that it does not reject again. Some of the Error Messages that are listed on the documents are as followed.

Error Message	Resolution

IMPORTANT: If a Work Breakdown Structure (WBS) has been established using a 'DEFAUT' Unique Asset ID (UAI) in FMMI, user must update the UAI immediately with the respective UAI number. (Refer to the Job Aid titled *Linking a WBS to a UAI for WIP Online Help Procedure*.

In the *Hold CPAIS UAI and other FMMI elements Table* in FMMI, the DEFAULT0000000000 UAI will be removed from the Table on June 1, 2018, therefore will no longer be available for users to select as the UAI for projects.

**5.** Listed below are some possible scenarios that the PAS will address based on the agencies' responses. The PAS will keep a log of how each scenario is handled along with the resolution.
